# Maintenance of car-park at Braishfield Village Hall / Braishfield Recreation Ground.

To agree that Braishfield Parish Council (as sole trustee of Braishfield Recreation Ground) reminds the trustees of Braishfield Village Hall of their obligation to maintain the access road/car-park in accordance with clause 3. (3) of the lease dated 12/2/1980 between Braishfield Parish Council and the Village Hall Trustees.

131. It was proposed that Braishfield Parish Council will undertake repairs currently required to the car-park at Braishfield Village Hall / Braishfield Recreation Ground on behalf of Braishfield Village Hall, due to Braishfield Village Hall having insufficient resources.

# To consider and respond to the report from Cllr White on amendments to the draft lease to the Football Club

- 132. It was proposed that Chairman John Bevan will meet with the football club to discuss their proposed amendments to the draft lease for the football pavilion before the Recreation Ground responds; but initial thoughts are:
  - Extending the season for use of the ground to 1 July to 31 May will probably be acceptable, provided community uses for the ground are given precedence.
  - Giving 28 days notice for maintenance is not possible, as the Recreation Ground employs a contractor to carry out mowing, and we do not know exactly which days

- they will mow; however, we are not aware of it having interrupted or prevented any football club use of the ground.
- The sole trustee of the Recreation Ground cannot comment on or commit itself to renewing the lease in 25 years time.
