THIS DEED OF APPOINTMENT is made the *twenty first* day of *September* One thousand nine hundred and fifty three B E T W E E N JOHN ERNEST HODDINOTT of Elm Grove Braishfield Romsey in the County of Southampton Farmer and DOROTHY CICELY LAVINIA BACON of Braishfield Lodge Braishfield aforesaid Spinster of the one part and BERTIE ALFRED ROSS of South View Braishfield aforesaid Builder of the other part and is supplemental to a Conveyance dated the 27th day of November One thousand nine hundred and twenty two and made between Alfred Charles King of the one part and Reginald Hugh Spencer Bacon William Gladstone Owen and the said Alfred Charles King of the other part by which the said property now known as the Braishfield Recreation Ground was conveyed by the said Alfred Charles King to the said Reginald Hugh Spencer Bacon and William Gladstone Owen and their heirs to the use of the said Reginald Hugh Spencer Bacon William Gladstone Owen and Alfred Charles King in fee simple Upon Trust to preserve the same subject to the provisions contained in the said Conveyance and is also supplemental to a Deed of Appointment dated the 6th day of September One thousand nine hundred and forty five whereby the said John Ernest Hoddinott and Dorothy Cicely Lavinia Bacon were appointed Trustees of the said Conveyance jointly with the said Reginald Hugh Spencer Bacon and William Gladstone Owen AND WHEREAS the said Reginald Hugh Spencer Bacon died on the 9th day of June One thousand nine hundred and forty seven AND WHEREAS the said William Gladstone Owen died on the 13th day of November One thousand nine hundred and fifty two AND WHEREAS the said John Ernest Hoddinott and Dorothy Cicely Lavinia Bacon are desirous of appointing the said Bertie Alfred Ross to be a Trustee of the said Conveyance and of the Braishfield Recreation Ground jointly with them the said John Ernest Hoddinott and Dorothy Cicely Lavinia Bacon

N O W THIS DEED W I T N E S S E T H that the said John Ernest Hoddinott and Dorothy Cicely Lavinia Bacon in exercise of the powers given to them by the Trustee Act One thousand nine hundred and twenty five and of every other power them hereunto enabling hereby appoint the said Bertie Alfred Ross to be a Trustee of the said Conveyance and of the Braishfield Recreation Ground jointly with them the said John Ernest Hoddinott and Dorothy Cicely Lavinia Bacon and THIS DEED ALSO WITNESSETH that in pursuance of the appointment hereinbefore contained the said John Ernest Hoddinott and Dorothy Cicely Lavinia Bacon hereby declare that all the property and chattels and the right to recover and receive all debts and other things in action subject to the trusts of the said Conveyance shall forthwith vest in the said John Ernest Hoddinott

Dorothy Cicely Lavinia Bacon and Bertie Alfred Ross according to the respective natures of such trust property respectively and as Trustee of the said Conveyance and of the Braishfield Recreation Ground as joint tenants for the purposes and upon the trusts thereof so far as the same are now subsisting and capable of taking effect
