Matters Arising

- (a) The Clerk read a letter he had received from the County Surveyor regarding the War Memorial.
It was decided to take no further action.
- (b) The Clerk was instructed to write to the County Educational Authority & find out if they were prepared to increase their payment for the use of the Recreation Ground as a result of the increase of the mowing charge.
- (c) The Clerk was instructed to deal with the funds of the Bransfield & District Horticultural Society.
- (d) There was no reply from :
the H.C.C. regarding the speed limit
the H.C.C. regarding pond cleaning.

The Election of Chairman & Vice-Chairman

Mr. C.H. Bartlam was re-elected Chairman & Mr. A. Gobbold was re-elected Vice-Chairman. Both elections were unanimous.

Correspondence

The Clerk read a letter from the Romsey & District Accident Prevention Council inviting the Council's representation & help in the prevention of accidents. The Chairman & Mr. Steiner said they would attend.

Recreation Ground

The Council discussed the proposals put forward by the Football Clubs for a new dressing room. The Council decided to accept, in principle, the proposal. The Council were, however, resolved to make sure that the following matters were to be observed:-

- (a) that the Football Clubs were to finish the building
- (b) that the Clubs would be responsible for maintaining, cleaning, insuring & financing the building
- (c) that no financial help should be given from the rates.
- (d) that in the event of the Football Clubs becoming defunct, the building would be removed.

In order to satisfy these conditions the Clerk was instructed

- (i) To enquire from the Hampshire + Isle of Wight Playing Fields Association whether or not a grant would be payable.
- (ii) To find out from the Hampshire + Isle of Wight Playing Fields Association if they could help in a legal capacity to draw up the conditions.
- (iii) To ask the Hampshire Association of Parish Councils whether they could offer any legal help.

Any Other Business

- (a) It was reported that a complaint had been received from Mr. Charles Head regarding encroaching wire from a property in Newport Lane. The Clerk was instructed to write to Mr. Bennett.
- (b) The Chairman signed the Audit Book in preparation for the audit of accounts.
- (c) Cheques in favour of:-

H. W. Baker £11.50
were drawn & signed.
- (d) The Clerk reported that having drawn these cheques the balance in hand was £12.27. A precept from the R.D.C. of £60 was signed.

(e) Mr. Kowman reported that ponies were being ridden along Footpath 9. Mr. Parsons & Mr. Cobbold said they would inspect the path & possibly erect concrete posts similar to those in the Recreation Ground.
