111. MINUTES

Resolved that the minutes of the last meeting held on 11th December 1978, be approved as a correct record and signed by the Chairman.

112. SILT ON ROADS

With reference to minute 110 (11.12.78), the Clerk submitted a letter from the Divisional Surveyor stating that he was aware of the silt problem near Pitt Farm and had submitted proposals for the provision of further soakaways in his estimates for 1979/80.

113. PROPOSED CEMETERY AT CROOKHILL

Further to minute 108 (11.12.78), the Clerk reported receipt of a letter from the Test Valley Borough Council stating that it would "keep the request under review should the Council decide to provide a cemetery in the vicinity of Crookhill".

With reference to minute 85 (13.11.78), the Clerk reported upon a notice concerning the next stage of the examination in public of the Structure Plan. The notice was on display on the Parish Council notice board.

120. HIGHWAY MATTERS

(a) Treatment of Roads

Resolved that the attention of the Divisional Surveyor be drawn to the concern expressed by many local residents at the extremely limited degree of treatment to roads in the Test Valley division during the recent heavy snowfall; and that particular attention be drawn to the extremely dangerous conditions that prevailed at the junction of the Braishfield Road with the A.31 (Winchester Road).

(b) Road Improvements

Resolved that the Clerk enquire of the Divisional Surveyor whether the road and pavement works have yet been completed outside of South View Cottage.
