

BRAISHFIELD PARISH COUNCIL

Minutes of the meeting of the Braishfield Parish Council held at the Womens' Institute Hall, Braishfield, on Monday, 8th October 1979 at 7.30 p.m.

Present: Mrs. B. M. Bell (Chairman) and Messrs. I. H. Chisholm, A. E. Cobbold, G. Shipton and J. A. Stewart. Mrs. J. Fahy (Footpaths Representative) was also in attendance.

Apologies: An apology for absence was submitted from Test Valley Councillor Mr. R. Corry.

65. MINUTES

Resolved that the minutes of the last meeting, held on 10th September 1979, be approved as a correct record and signed by the Chairman.

66. WATER SUPPLY TO VILLAGE/ROAD RESURFACING

With reference to minute 42 (10.9.79) the Clerk reported upon his discussions with the authorities concerned.

67. MAINTENANCE OF FOOTPATHS

Further to minute 46 (10.9.79), Members reported upon their investigations as to ways in which local organisations might assist in the maintenance of footpaths.

Resolved that an informal meeting be held on Monday, 29th October at 7.30 p.m. with the appropriate organisations and interested landowners to discuss arrangements for the maintenance of public footpaths within the Parish; and that the organisations be invited to each send not more than two representatives to this meeting.

68. PROPOSED VILLAGE HALL

Further to minute 58 (10.9.79), the Chairman submitted a draft lease prepared by Messrs. Bell, Pope and Bridgwater.

Resolved that the Solicitors be asked:-

- (a) if the reference in recital (3) to "a right of access" is sufficiently explicit in legal terms;
- (b) to amend the annual payment to £1.00 (Clause 1);
- (c) to insert six months as the period within which the access is to be constructed (Clause 2); and,
- (d) to advise as to the desirability of an indemnity clause being inserted in respect of third party liability.
