155 A. MINUTES

Resolved that subject to, in minute 154(a) the substitution of "Paynes Hay" for "Lower", the minutes of the meeting held on 11th February, and of the special meeting held on 25th February 1980, be approved as correct records and signed by the Chairman.

156. TVS 1789/1 - OUTLINE: ERECTION OF DWELLING - WENGEN, CHURCH LANE, BRAISHFIELD: MR. AND MRS. D. E. PARE

Resolved that the Test Valley Borough Council be informed that this Parish Council raises no objection to the principle of this proposed development, subject to the following:-

- (a) the development should be in the form of a bungalow;
- (b) the access should be at the widest point of the lane; and
- (c) attention being drawn to the fact that the ditch running alongside the site occasionally carries foul effluents.

157. WEIGHT RESTRICTIONS ON 'C' CLASS ROADS

Further to minute 139 (11.2.80) the Clerk submitted copies of the document "Lorries in Hampshire" for circulation amongst the Members and for further consideration at the next meeting.

158. PROPOSED VILLAGE HALL

Further to minute 150 (11.2.80), the Clerk submitted a letter from Messrs. Bell, Pope and Bridgwater confirming completion of the lease in favour of the Village Hall Trustees relating to access across the recreation ground. The lease was dated 12th February, runs for a period of 99 years from 1st January 1980 and the annual rent of £1.00, if demanded, is payable on 1st January in every year.

It was further reported that work on the site of the proposed hall had commenced and that the site was 75% cleared.

The Clerk also informed the Council that the formal application for loan consent for the sum of £8,233 had been submitted on 29th February.

Resolved that permission be granted.

Resolved that the Parish Council be not represented at the Councillors' Day to be held at Nursling and Rownhams Village Hall on 19th April 1980.

165. NATIONAL CONFERENCE OF LOCAL COUNCILLORS - 17/18TH APRIL 1980

Resolved that the Parish Council be not represented at this Conference, organised by the National Association of Local Councils.

166. RURAL LIFE - CHANGE OR DECAY

A document presented by the National Association of Local Councils expressing the views of Parish, Town and Community Councils on this subject was submitted.
