103. PARISH COUNCIL - CASUAL VACANCY

Further to minute 91 (10.11.80), the Clerk reported receipt of a letter from Test Valley Borough Council stating that, notice in writing having been received from at least two parish electors, arrangements were being made for an election to fill the vacancy created by the resignation of Mr. Cobbold. If contested, a poll would take place on Thursday, 29th January 1981.

104. BUS SHELTER

With reference to minute 92 (10.11.80) a tender in the sum of £77.50 plus V.A.T. was submitted from R. J. Monk Limited.

Resolved that this tender be accepted.

105. RECREATION GROUND - CHILDRENS' PLAY AREA

Further to minute 94 (10.11.80), the Clerk submitted letters from Municipal Mutual Insurance Limited and Charles Wicksteed and Company.

Resolved that consideration of this matter be deferred to the next meeting, to enable a quote to be obtained locally for the cost of securing the tree trunk.

106. ROAD JUNCTION - JERMYNS LANE/SANDY LANE, ROMSEY EXTRA

Arising from minute 100 (10.11.80) the Clerk submitted a letter from the County Divisional Surveyor stating that advance warning of give-way signs had now been erected 100 yards each side of the major road.

Resolved that the Divisional Surveyor be thanked for his attention to this matter which, it is hoped, will do much to alleviate the problem.

111. APPEAL BY MR. J. G. MUSSELWHITE AND MRS. M. R. STITT: OUTLINE PLANNING PERMISSION FOR ERECTION OF DWELLING AND GARAGE - NO. 2 THE SQUARE AND APRIL COTTAGE, BRAISHFIELD

The Clerk reported that the appeal in respect of this planning application was to be decided by the Secretary of State for the Environment on the basis of written statements. The Council was invited to submit any views on the proposals.

Resolved that the Secretary of State be informed that members of the Council have received no objections from parishioners and the Parish Council has no objection in principle to this proposed development.

112. PROPOSED VILLAGE HALL - GRANT INSTALMENT

114. RECREATION GROUND - BRAISHFIELD FOOTBALL CLUB

A letter, dated 28th November, was submitted from the Football Club seeking retrospective permission for the erection of a small shelter on the recreation ground for use by efficials.

Resolved: -

- (a) that the Football Club be informed that the Council regrets that permission was not obtained prior to the erection of the shelter and that any future activities that are not covered by the terms of the licence must be first approved by the Council;
- (b) that the Football Club be asked to confirm that its insurance policy covers third party liability at all times in respect of this structure;
- (c) that the attention of the Football Club be drawn to the fact that the shelter is becoming a harbour for litter; and
- (d) that, subject to satisfactory arrangements in respect of (b) above, the Parish Council agrees to the shelter remaining in situ until the end of this season's league fixtures, subject to the Football Club keeping it in cleanly order.

115. HER MAJESTY THE QUEEN MOTHER: SOTH BIRTHDAY - COMMEMORATIVE TREE

The Chairman submitted a letter from Hilliers Nurseries concerning the planting of commemorative trees. Members of the Council agreed to submit any proposals to a future meeting.

116. THE WHITBREAD-LAURENT PERRIER AWARD

Resolved that this Council supports, with best wishes, the Twinning Association's entry for this award, which is designed to promote Franco-British co-operation.

117. HIGHWAY MATTERS

Resolved:-

- That the attention of the County Divisional Surveyor be drawn to the following previously reported problems that still persist and that he be asked to remedy these matters:-
 - (a) erosion of the surface of the road at the junction in The Square (minutes 52 28.7.80, and 61 8.9.80 refer); and
 - (b) water gushing from the Manor direction, down Paynes Hay Road and into Eldon Road (minute 154 11.2.80 refers).
