134. MINUTES

5. ELECTION OF MR. P. WATKINS

The Chairman extended a welcome to Mr. P. Watkins who had been elected to fill the vacancy created by the resignation of Mr. A. E. Cobbold. The Clerk reported that Mr. Watkins had signed the Declaration of Acceptance of Office.

136. FOOTPATH NO. 8, BRAISHFIELD

Further to minute 129 (12.1.81), the Chairman reported that the Ramblers Association had now lodged an objection to the proposed diversion of this footpath.

Messrs. Myers and Wallace of the Association attended the meeting; outlined the basis on which the objection had been lodged; and reported that there was some doubt as to whether the application to divert the footpath would now proceed.
