# BRAISHFIELD PARISH COUNCIL

Minutes of the meeting of the Braishfield Parish Council held at the Womens' Institute Hall, Braishfield, on Monday, 13th April 1981, at 6.30 p.m.

Present: Mrs. B. M. Bell (Chairman), and Messrs. I. H. Chisholm, G. Shipton, J. A. Stewart and P. Watkins.

# 177. MINUTES

Resolved that the minutes of the meeting held on 9th March 1981, and of the special meeting held on 6th April 1981, be approved as correct records and signed by the Chairman.

# 178. MR. A. E. COBBOLD

Further to minute 91 (10.11.80) and to a number of informal discussions held since that date, it was reported that a silver tray, suitably inscribed, had been purchased and would be formally presented to Mr. Cobbold at the Annual Parish Meeting. The presentation was to commemorate thirty three years loyal service by Mr. Cobbold.

Resolved that the account of Underhill House, in the sum of £27.71, for the supply and engraving of the tray, be paid.

# 179. THE MOUNTBATTEN MEMORIAL TRUST

Arising from minute 155 (9.3.81), the Clerk submitted a letter from the District Auditor confirming that a financial contribution to this Trust would classify as allowable expenditure under the provisions of Section 137 of the Local Government Act, 1972. This information had been transmitted to the Trustees. It was understood, however, that there was an element of doubt as to whether the Youth Hostel project would proceed.

Resolved that the question of whether or not to make a contribution to the Trust be deferred pending further information from the Trustees.

# 180. RECREATION GROUND - CHILDRENS PLAY EQUIPMENT

The Clerk submitted a letter, dated 23rd March, from Charles Wicksteed and Company enclosing the report of their engineer on the condition of the playground equipment.

A letter dated 10th April, was also received from the Village Hall Management Committee apologising for the fact that the see-saw had been removed during the construction of drainage works, but would be replaced as soon as possible.

Resolved that the positions be noted.

A letter dated 26th March was submitted from the Local Government Boundary Commission for England, making reference to a review requested by the Test Valley Borough Council affecting the Parishes of Kings Somborne and Crawley.

Resolved that the request of the Horticultural Branch of the Village Association to use the recreation ground on 25th July, for the annual Flower Show, be approved, and that the Football Club be advised of the date of this event.

Further to minute 174 (9.3.81) the Chairman submitted a letter from a parishioner expressing concern at the "urbanisation" of this footpath.

The Parish Council was sympathetic with this sentiment, but pointed out that the steps were provided for safety reasons and that the resurfacing of the footpath was at the request of a parishioner. It was not intended that other footpaths be improved to this standard, but the one in question was used extensively by parishioners.

# 193. HIGHWAY MATTERS

Resolved that the Council's appreciation be conveyed to the County Divisional Surveyor for having provided the hardstanding by the telephone kiosk and for tidying up the corner by the Church Rooms.

# 194. TEST VALLEY ASSOCIATION OF PARISH COUNCILS

Mr. P. Watkins reported upon his attendance at the meeting of the Association on 19th March.

Resolved that the Council's appreciation be extended to Mr. Watkins for his attendance at the meeting and for his report on the proceedings.
