

BRAISHFIELD PARISH COUNCIL

Minutes of the meeting of the Braishfield Parish Council held at the Village Hall, Braishfield, on Monday, 11th January 1982 at 7.30 p.m.

Present: Mr. G. Shipton (Chairman), Mrs. B. M. Bell, and Messrs. I. E. Chisholm, J. A. Stewart and P. Watkins.

105. MINUTES

Resolved that the minutes of the meeting held on 14th December 1981, and of the special meeting held on 5th January 1982, be approved as correct records and signed by the Chairman, subject to an apology for absence being recorded from Mr. I. H. Chisholm in respect of the latter meeting.

106. APPOINTMENT OF CLERK

Further to minute 97 (14.12.81) the Chairman reported that Mr. M. Sherwood had been interviewed and had been offered the appointment of Clerk at a commencing salary of £250 per annum, plus the usual out-of-pocket expenses and a travelling allowance at the rate of 10p per mile. It had been agreed that the terms be reviewed in six months time.

Resolved that the above action be confirmed; that Mr. Sherwood commence his duties on 1st February 1982; and that the period of notice to terminate the appointment, by either side, be two months.

107. LITTER BIN AT BUS STOP

With reference to minute 95 (14.12.81) the Chairman reported that he was endeavouring to agree the siting of the litter bin.

108. PARISH REVIEW

The Clerk submitted a letter, dated 30th December 1981, from the Borough Council enclosing the draft submission to the Local Government Boundary Commission in respect of the proposed boundary changes affecting Braishfield.

109. BOROUGH COUNCIL PLANNING MINUTES

The Clerk submitted the minutes of meetings of the Planning and Development Committee held on 9th December 1981 and of the Southern Area Planning Sub-Committee held on 22nd December 1981, together with delegated decisions for the period commencing 24th November 1981.

110. VILLAGE HALL GRANT

Resolved that the instalments of grant in the sums of £500 and £233, being the final instalment, be paid to Hampshire County Council; and that the sum of £1,000 be transferred from the Council's Deposit Account to the Current Account.

The Chairman reported that between meetings he had consulted with other Members of the Council and had subsequently instructed the Clerk to advise the Borough Council that no objection was raised to the principle of this proposed development, but that the Parish Council felt that the garage should be located further back into the site to conceal it from the highway.

Resolved that the above action of the Chairman be confirmed.

113. HIRE OF VILLAGE HALL COMMITTEE ROOM

Resolved that the fee for the hire of the Committee Room for every second Monday in the month, except August, be paid in the sum of £22.

114. MR. H. STEINER

With deep regret the Chairman reported the death on Saturday, 9th January 1982, of Mr. H. Steiner. A former Member of the Parish Council and most respected parishioner, Mr. Steiner would be sadly missed.
