(A) Upkeep of Recreation Ground

(B) Fouling of Recreation Ground by Dogs

The Chairman reported receipt of three letters complaining at the fouling of the Recreation Ground by dogs.

RESOLVED:

- (i) That an appropriate notice be posted on the Recreation Ground requesting dog owners to refrain from allowing their dogs to foul the Recreation Ground.
- (ii) That the Clerk be requested to consult with the Home Office over the possibilty of the introduction of byelaws aimed at prohibiting the fouling of the Recreation Ground by dogs.

- (iv) That the Chairman be requested to submit an appropriate article on the subject for inclusion in the next edition of the Braishfield Newsletter.

125. HIGHWAY MATTERS

(A) The Borough Council of Test Valley(Off Street Parking Places, Romsey)Order 1982

(B) Road Sign at The Wheatsheaf Public House, Braishfield

The Chairman reported that he had carried out certain necessary repairs to the sign.

(C) Access Sign in Newport Lane, Braishfield

RESOLVED:

That the Clerk be requested to advise the Divisional Surveyor that the access sign had been removed from its usual position and placed outside the Telephone Box.

(D) Effluent Seepage - The Square, Braishfield

RESOLVED:

That Mr. Corry be requested to draw the attention of the Chief Environmental Health Officer, Test Valley Borough Council, to the seepage of effluent from a cess pit into the road at The Square. Braishfield.

(E) Mud on Road

(a) Kiln Lane

The Chairman reported that the Divisional Surveyor proposed depositing excess road material in the gateway adjacent to the footpath into the field at the top of Kiln Lane, to overcome complaints over the muddy conditions in the gateway.

(b) Bunny Lane

RESOLVED:

That the Clerk be requested to draw the attention of the Divisional Surveyor to the problem of mud on the road at Bunny Lane.

(F) Suggested Traffic Sign at Road Junction at bottom of Common Hill, Braishfield

RESOLVED:
