#### 128 MINUTES

#### (B) Damaged Verge - Church Lane

Attention was drawn to the damage caused by vehicles having to park on the verge in Church Lane as a result of the parking place there being occupied for long periods by builders' vehicles. The Chairman undertook to investigate the matter.

## 135 WOMEN'S INSTITUTE HALL SITE, BRAISHFIELD AND APRIL COTTAGE, BRAISHFIELD

The Parish Council received a detailed account of the circumstances relating to drainage requirements at the Women's Institute Hall site and April Cottage and its adjoining building plot.

RESOLVED:

- (i) That the Test Valley Borough Council be advised that the Parish Council view with concern the situation of owners of plots with extant planning permissions on them having to bear the additional cost of providing sealed cesspools for individual new houses, bearing in mind the imminent provision of mains drainage for Braishfield.
- (ii) That, in the circumstances, the Parish Council support the request of Mr. J. Musselwhite for drainage on a temporary basis into the septic tank at April Cottage pending the provision of main drainage.

## 136 RECREATION GROUND - ADDITIONAL RECREATION FACILITIES

#### RESOLVED:

That the possibility of providing additional recreational facilities at the Recreation Ground be discussed at the Annual Parish Meeting.

## 137 PRECEPT
