(2) Provision of seats

RESOLVED:

That the generous offer of the Women's Institute to provide three seats on the Recreation Ground be accepted with thanks.

25. HIRE OF BRAISHFIELD VILLAGE HALL

On a point of clarification, Mrs. Bell drew attention to the fact that the bookings listed under Minute 14 of the last meeting had included hirings made by persons and organisations from within the area of benefit whereas the Agreement entered into between the Village Hall Management Committee and Mr. Watkins providing for a restriction on the hours during which the playing of music in the Hall was permitted, related to hiring persons or organisations from outside the area of benefit only, (hence the correction contained in Minute 17 above). A further application from a person outside the area of benefit was considered.

That the Village Hall Management Committee be advised that the Parish Council raise no objection to the hire of the Hall for a discotheque on Saturday 10th July 1982 on condition that the event finishes by 11.30 pm.
