#### RESOLVED:

#### 49. HIGHWAY MATTERS

## (1) Suggested Traffic Hazard Sign by former Women's Institute Site

The Clerk reported receipt of a letter from the Braishfield Village Association seeking the Parish Council's views on the possibility of providing traffic signs warning of dangerous bends on the main road through the village by the former Women's Institute Site.

#### RESOLVED:

That the Braishfield Village Association be advised that whilst the Parish Council sympathise with their concern, they feel that it would be unlikely that the Divisional Surveyor would be prepared to accede to the request, and propose instead therefore, to request him to utilize part of the verge outside "Cherry Hills" for the purpose of widening the roadway.

## (2) Dropping of Kerb - Chapel Close

#### RESOLVED:

That the Divisional Surveyor be requested to consider the possibility of dropping the kerb at Chapel Close, Braishfield to permit easier passage of prams and wheelchairs.

## (3) "Four Winds", Braishfield - Enforcement Action

The Clerk reported receipt of a letter from the Braishfield Village Association regarding obstruction on the road outside "Four Winds". He advised that Test Valley Borough Council were instituting fresh Enforcement proceedings against the owner of "Four Winds" in respect of the unauthorised activities at his property.

#### RESOLVED:

That the Parish Council support Test Valley Borough Council in their decision to institute enforcement proceedings against the owner of "Four Winds", Braishfield, and the Braishfield Village Association be advised accordingly.
