Arising thereon:-

Minute 57 (1) Recreation Ground - Fouling by Dogs

RESOLVED:

That the Clerk be requested to arrange with Hampshire County Council for the construction of an enamelled sign in accordance with the details contained in Minute 57 (1) of 11th October 1982, at an estimated cost of £40.

Minute 57 (2) Recreation Ground - Purchase of Litter Bin

The Clerk reported that further investigations had revealed that the cost of a litter bin of the type required would in fact be in the region of £42.

(1) Jermyns Lane Crossroads

The Clerk reported receipt of the following letters from

(a) the Divisional Surveyor, advising that although he did not consider that the hedges at the crossroads required trimming at the present time he would keep the situation under review. He pointed out however that strictly, hedge cutting was the responsibility of the adjacent landowners.

(b) the Clerk of Romsey Extra Parish Council, advising that he had written subsequently to the landowners requesting them to lower the height of the hedges when cutting to improve visibility for drivers approaching the crossroads.

The Parish Council also noted that the Braishfield Village Association had made strong representations to the County Council via Romsey Extra Parish Council for the introduction of greater safety measures at the junction. Members reiterated their view that the solution to the problem lay in the staggering of the crossroads although this suggestion had in the past been rejected.

(2) Kiln Lane - 6' 6" Restricted Access Sign

RESOLVED:

That the Divisional Surveyor be requested to re - erect the fallen 6' 6" width restriction sign at the point where Kiln Lane adjoins Braishfield Road.

(3) C.91, Manor Corner, Braishfield to Kings Somborne

RESOLVED:

That Kings Somborne Parish Council be asked to consider requesting Hampshire County Council to impose a 6' 6" width restriction order on the stretch of Road C91 from Manor Corner, Braishfield to Kings Somborne.

(4) Clearance of Storm Drains and Ditches

That the Divisional Surveyor be requested to clear the storm drains/ditches of excess soil and/or leaves at the following points:-
