85 MINUTES

The Minutes of the meeting held on 13th December 1982 were approved as a correct record and signed by the Chairman subject to the resolution to Minute 80 being amended to read "That the Divisional Surveyor be requested to consider the possibility of improving the layout of the road at The Square Braishfield" Arising on Minute 80 the Clerk reported receipt of a letter from the Divisional Surveyor advising that he would look into the matter but reminding the Parish Council of the financial constraints currently obtaining.

86 PLANNING MATTERS

- (1) TVS 3061/2 - Erection of Dwelling, rear of April Cottage and 2 The Square Braishfield

RESOLVED:

That no objection be raised in respect of the application but that Test Valley Borough Council be advised that as the position of the proposed property's cess pit is not shown on the plans, they are unable to comment on this aspect.

- (2) TVS 3890 - Erection of Dwelling, Deal Cottage, Newport Lane, Braishfield

RESOLVED:

That no objection be raised in respect of the application but that Test Valley Borough Council be advised of the following Parish Council observations:-

(a) Concern is expressed at the proximity of the proposed buildings to the narrow lane.

(b) The Parish Council are doubtful as to whether the layout of the building as proposed leaves sufficient room for a motor vehicle to manoeuvre in and out of the garage.

(c) It is felt that a pitched roof would be preferable to the flat roof shown on the plans.

- (3) TVS 2021/1 - Proposed Fuel Storage Tanks - 6 Megana Way, Braishfield
