44 PLANNING MATTERS

(a) TVS 370/1 - Proposed Grain Store, Pitt Farm, Braishfield

The Parish Council received copies of letters of objection from local residents.

RESOLVED:

That strong objection be raised in respect of Application TVS 370/1 on the following grounds:-

- (a) Adverse affect on the amenity of the village.
- (b) Volume and type of traffic which would be generated on the narrow Kings Somborne Road would be unacceptable.
- (c) Access to the site both dangerous and inappropriate in the position proposed.
- (d) Loss of visual amenity caused by destruction of part of copse to accommodate the development.

- (e) Dust problems which would be generated by the proposal.
- (f) Size of the development particularly in view of its proximity to private dwelling houses.

47 HAMPSHIRE MINERALS LOCAL PLAN

(The Clerk reported that it was probable that he would be appointed Programming Officer for the Inquiry into the Hampshire Minerals Local Plan and that it was important therefore that he observed strict neutrality in the matter. Accordingly he took no part in the ensuing discussion and the undermentioned Minute was prepared by the Vice-Chairman).

RESOLVED:

That Hampshire County Council be informed that Braishfield Parish Council whilst appreciating the national need for supplies of aggregates from appropriate sites and the safeguards so stated in the criteria, object to the proposed workings in Preferred Area 14 of the Hampshire Minerals Local Plan for the following reasons:-

- (1) Concern at the threat to the amenity of the village which these workings would create with the probable expediency use of unsuitable village lanes by heavy traffic to and from Bunny Lane.
- (2) Particular concern at the undefined boundary on the eastern border of the workings within the parish and the precedent which such workings might create for extension into the sand bearing deposits closer to the village itself.
