14. MINUTES

The Minutes of the Meeting held on 14th May 1984 were agreed as a correct record subject to the recording of Councillor Wyss 'apology for absence.

MID TEST LOCAL PLAN

The Parish Council accepted the view expressed by Test Valley Borough Council that further discussion of this matter between the two Authorities at this stage, would be premature.

16. AUDIT FEE 1983/84

RESOLVED:

17. WATER SUPPLY TO ALLOTMENTS

The Clerk reported correspondence from Mr. Lalonde which indicated that the total cost of supplying the water supply to the allotments (including the Southern Water Authority tapping charge and the provision of one standpipe) would amount to £480.10

RESOLVED:

That a contribution of £80 be made by the Parish Council towards the maintenance of All Saints Churchyard in respect of 1984/85.

19. RECREATION GROUND

(1) Plaques for Seats

RESOLVED:

That approval be given to the payment to Walter Lehmann & Son of the sum of £28.50 in respect of the supply and engraving of brass plates for the Recreation Ground seats.

(2) Mowing of Recreation Ground

The Chairman reported that he had arranged for the Divisional Surveyor to mow the Recreation Ground on a "one-off" basis pending further discussions with Braishfield Football Club on long-term arrangements for carrying out the work.
