

Minutes of the meeting of Braishfield Parish Council held on 11th March, 1985 at the Village Hall, Braishfield (7.30 p.m. to 8.30 p.m.)

PRESENT: P. Watkins (Chairman); I. Chisholm, G. Shipton and J. Stewart.

(Apologies for absence were received from Mrs. P. Saunders and Cllr. J. Wyss)

115. MINUTES.

RESOLVED that the minutes of the meeting held on 11th February, 1985 be signed by the Chairman as a correct record.

116. PLANNING APPLICATIONS.

(a) TVS.45555 - Extension to Jacobs Folly.

RESOLVED that no objection be raised to the above application.

(b) TVS.380/1 - erection of agricultural worker's dwelling at Pitt Farm.

RESOLVED that no objection in principle be raised to the proposal but the Chief Planning Officer be informed of the Parish Council's concern that any new buildings be kept in sympathy with existing adjoining buildings.

117. REPORTING OF CORRESPONDENCE.

The Chairman reported the receipt of a letter from the Village Association indicating that the Association would in future request certain letters to be read in full at Parish Council meetings and would circulate copies of these to Council members.

RESOLVED that the position be noted.

118. LITTER CLEARANCE.

RESOLVED that a donation of £10 be paid towards the costs to be incurred by the Braishfield Village Association in the organisation of the annual village litter clearance event to be held on Saturday, 23rd March.

119. EYE HOSPITAL.

The Clerk reported on a request from the Community Health Council for the Parish Council's views on the proposals to re-site the Southampton Eye Hospital at either the General Hospital complex or the Royal South Hants site.

RESOLVED that the Community Health Council be informed that provided adequate car parking was provided, the Parish Council would prefer new Eye Hospital facilities to be provided within the Southampton General Hospital complex.

120. HIGHWAYS.

(a) Roadside Ditches.

RESOLVED that the Divisional Surveyor be informed that the drainage ditch in Kiln Lane outside Fairbourne Farm had collapsed.

(b) Road Surface.

RESOLVED that the Divisional Surveyor be requested to take urgent action to repair a number of potholes on roads in the Parish and in particular those in Butchers lane.

(c) Vehicle Parking.

RESOLVED that the Chairman pursue the problem of vehicles parking on the highways at night without lights with the local Police.

121. BUS STOP.

RESOLVED that the Bus Company be informed that the bus stop in Braishfield between Megana Way and the Dog and Crook public house had been uprooted.

122. RECREATION GROUND.

The Chairman reported on discussions he had had with the Chairman of the Football Club concerning the future arrangements for the cutting of the recreation ground.

123. SALARY AND EXPENSES.

RESOLVED -

- (a) That with effect from April 1985 the Clerk's salary be increased to £310 p.a.; and
- (b) That the Clerk's salary in the sum of £23.08 together with expenses totalling £5.32 to date be paid.
