36. MINUTES.

RESOLVED that the minutes of the meeting held on 10th June be signed by the Chairman as a correct record subject to the substitution of footpath 13 for footpath 14 in minute no. 28.

PLANNING APPLICATIONS.

38. FOOTPATH 13.

Miss Saunders reported that she had inspected the above footpath with Miss Fahy, the footpaths representative and commented on the condition of the surface of the path which she considered to be unsuitable for users.

RESOLVED that the County Rights of Way Officer be informed of the dangerous condition of the footpath and requested to carry out an inspection with a view to improving the path's surface.

39. PARISH COUNCIL VACANCIES.

The Clerk reported that the Returning Officer had confirmed that there were two candidates for the forthcoming Parish Council by-election which was to be held on 8th August.

40. RECREATION GROUND.

Pruning of Trees.

RESOLVED that Twixwell Ltd. be paid the sum of £25.88 for the pruning of trees overhanging the footpath.

(2) Fouling of Ground.

(3) Use of Recreation Ground.

RESOLVED that the action of Chairman in authorising the use of the ground for a picnic by the local Girl Guides be confirmed.

41. REPRESENTATIVES ON OUTSIDE BODIES.

The Clerk reported that Dr. J. Edwards had indicated that he did not consider it appropriate for him to continue as the Parish Council's representative on the school governing body as he no longer had children attending the school.

RESOLVED that Miss P. Saunders be appointed as the Parish Council's second representative on the governing body of the Braishfield Primary School.

42. HIGHWAY MATTERS

(1) Overhanging hedges - Newport Lane.

RESOLVED that the Chairman request the owners of properties in Newport Lane to trim their hedges where they were overhanging the highway.

(2) Potholes.

RESOLVED that the attention of the County Surveyor be drawn to several deep potholes in the surface of the highway between Braishfield House and the crossroads near Manor Cottage.

(3) Roadside Ditch - Rudd Lane.

The Clerk reported that the Borough Council's Chief Environmental Health Officer had completed investigations into the pollution of the roadside ditch in Rudds Lane and confirmed that measures would be taken to prevent similar problems of this nature occurring again.
