### 53. MINUTES.

RESOLVED that the minutes of the meeting held on 18th September, 1986 be signed by the Chairman as a correct record.

### 54. PLANNING APPLICATIONS.

TVS.5139 Extension at Willow Trees, No objection. The Square.

TVS.5145 Extension at Worsley Lodge, No objection in Common Hill Road. Principle to the proposals subject to the possible improvement of the front elevation to the garage.

TVS.5144 Continued use of farm No objection. building for craft industry at Hawkes Farm.

### 55. SOUTHERN AREA PLANNING SUB-COMMITTEE.

The Parish Council received the agenda for the meeting of the Sub-Committee held on 2nd October, 1986 and noted those items which related to Braishfield.

### 56. MEETING OF REPRESENTATIVES OF SOUTHERN PARISHES.

Mr. Shipton reported on a meeting which had been convened by the Romsey Town Council and to which he and the Vice-Chairman had attended. The meeting had been called primarily to consider possible joint action by the Southern Parishes of Test Valley on major planning and development matters affecting the area. The Braishfield representatives had highlighted the problems of the Jermyns Lane/Braishfield Road crossroads as a main issue of concern in Braishfield. It was proposed that future meetings of the group be held twice a year and hosted by Romsey and that the next meeting be held on Thursday, 6th November.

RESOLVED that the position be noted and Braishfield continue to be represented at the meetings.

# 57. HIGHWAY MATTERS.

RESOLVED that the Clerk remind the County Surveyor about the following outstanding matters: Footpath works, Chapel Close speeding vehicles in village and Jermyns Lane junction - meeting with County representatives.

# 58. RECREATION GROUND.

The Clerk reported the receipt of a letter from the Braishfield Football Club inviting Parish representatives to their next committee meeting on Sunday, 19th October. Consideration was given to a draft agreement relating to the use of the recreaton ground by the football club and Mr. Musselwhite agreed to assist with any supervision for the use of the ground.

#### RESOLVED -

- That the football club be requested to enter into an agreement the form of which is appended to the minutes;
- (2) That the Chairman and Mr. Musselwhite attend the meeting of the football club and discuss with them the provisions of the agreement; and
- (3) That Mr. Musselwhite be appointed the Parish Recreation Ground representative and that he co-ordinate any decision for the cancellation of football matches in inclement weather.

## 59. BUS SERVICES.

Mr. Chisholm, the Parish transport representative, reported that the Wilts and Dorset Bus Company had contracted to continue operating the school bus service and had been successful in the tender for the operation of the remaining services in Braishfield.

# 60. ACCOUNTS.

RESOLVED that the Clerk's salary in the sum of £29.17 together with expenses to date totalling be paid.

## AGREEMENT BETWEEN BRAISHFIELD PARISH COUNCIL AND BRAISHFIELD FOOTBALL CLUB

# ON THE TERMS FOR USE OF THE VILLAGE RECREATION GROUND

- (1) The BRAISHFIELD FOOTBALL CLUB will be permitted use of the Braishfield Village Recreation Ground against a contribution for each home fixture payable at the end of each calendar month.
- (2) The arrangements which will be reviewed annually, will cover the use of the ground for home fixtures. No contributions will be necessary for training sessions.
- (3) A schedule of the dates and times of the intended use of the ground and facilities by the Football Club are to be notified to the Chairman of the Parish Council at the commencement of the season. The schedule will be accepted subject to any bookings of the Recreation Ground by other village organisations or schools.
- (4) Any change in this schedule of use must be notified to the Chairman of the Parish Council and will only be accepted if there is no prior booking by other organisations. Whilst the Parish Council will seek to accommodate the Football Club whenever possible, the Club cannot be presumed to have an automatic right to the use of the ground.
- (5) At all times the reasonable requests of the Parish Council and their officials must be complied with.

(6) Any matter arising from the use of the Recreation Ground by the Football Club and not covered by this agreement shall be determined by the Parish Council, after due consultation with the Football Club.

(7) It shall be the responsibility of the Football Club to use the Recreation Ground in a reasonable and proper manner and to leave the pitch clear and free of obstructions including goal posts after every game. Any damage caused to the surface of the recreation ground as a result of its use by the Football Club shall with the prior consent of the Parish Council be reinstated by the Football Club at their expense.

(8) In inclement weather the Parish Council will prior to a match determine whether ground is suitable for play and if unsuitable will notify the Football Club accordingly. The Parish Council's decision will be final.

The Braishfield Football Club hereby agree to the above conditions in respect of the use of the Braishfield Recreation Ground during the 1986/87 season.
