## 111. MINUTES.

#### 112. PLANNING.

(a) Planning Application

TVS.2453/l Extension at Manor Cottages

No objection subject to the materials matching those of the existing dwelling.

(b) Planning Appeal.

The Clerk reported that the Borough Council had been informed that the appeal by R. Emery in respect of planning application 2147/7 - revised details of dwelling and garage at Merrymead Farm, Church Lane had been allowed.

### 113. NOTICE OF AUDIT.

The Clerk reported that the annual audit of accounts would take place on Monday, 18th May and that the relevant documents would be held on deposit at the Braishfield Garage.

#### 114. MOTHER AND TODDLER GROUP.

Consideration was given to a letter from Mrs. Musselwhite informing the Council of the activities of the Braishfield Mother and Toddler Group. The group was well attended and was considered to be of great use to the community. Although some equipment had been acquired from funds, additional funds and contributions were required and a request for assistance from the Parish Council was made.

RESOLVED that the Parish Council agree in principle to assisting the group but that further consideration be given to the way this may best be achieved at the next meeting of the Council.

## (c) Tree Planting.

The Chairman reported that John Hillier had been consulted about a suitable tree for planting by the Mayor of Crouay. This would be sited between the play area and the car park. It was suggested that other local organisations might like to donate trees to complete a planting scheme and the Chairman informed the meeting that Mr. Hillier would also be prepared to select suitable trees for such a scheme and to make enquiries about the possibility of grant aid.

# 117. HIGHWAYS.

The Clerk referred to a telephone conversation a resident of Braishfield had had with the County Council concerning the dangers of the Braishfield Road/Jermyns Lane crossroads. Concern was also expressed about a manhole cover in the footway outside "Potters Clay", Braishfield Road.
