14. MINUTES

RESOLVED -

That the Minutes of the Annual General Meeting held on 17 May 1990 be signed by the Chairman as a correct record.

15. PLANNING APPLICATIONS

TVS6463 - Replacement Dwelling at 7 Megana Way

RESOLVED -

That no objection be raised to this application.

TVS249/11 - Extension at Hunters Lodge, Dores Lane

RESOLVED -

That no objection be raised to this application subject to the materials being in keeping with neighbouring properties.

16. DRINKWISE CAMPAIGN

It was reported that the Borough Council had launched a campaign on the 12th June 1990 which would promote sensible drinking within safe levels. The public were given the opportunity to sample low and no-alcohol drinks free of charge at the launch.

17. TOUR OF THE BOROUGH

It was reported that the Mayor of Test Valley Borough Council had arranged a tour of the Borough for representatives from Parish Councils on Saturday 14 July. Two representatives from Braishfield had been invited to join the tour.

RESOLVED -

That the offer be noted and that Parish Members wishing to participate notify the Chairman.

18. HIGHWAY MATTERS - PARISH FOOTWAYS

In response to a complaint about the condition of the footways in the parish an inspection had been carried out by the Area Surveyor who informed the Parish Council that these had been found to be in a reasonable condition compared with others in the Romsey area. It was accepted that there were depressions in that section between the Garage and Newport Lane and had been added to the list of footways requiring remedial action.

RESOLVED -

That the position be noted and the Area Surveyor be informed of the numbers of pedestrians having to walk in the road to avoid the uneven surface of the pavement.

19. FOOTPATHS

The County Rights of Way Officer had informed the Parish Council of action he had taken to require the repair of stiles on Braishfield Footpaths Numbers 1 and 14. Failure by the land owner to carry out the repairs would result in the work being carried out by the County Council and the costs being recharged to the owner.

Reference was also made to the footpath clearance work to be carried out by the Scouts as part of their Community Explorers Badge.

RESOLVED -

That the position concerning Footpaths 1 and 14 be noted and that D Butterfield enquire about the progress being made by the Scouts on the Clearance Programme.

20. RECREATION GROUND

(A) Braishfield Beer Race

The Chairman reported that in response to a request from the Romsey Road Runners he had approved the use of the Recreation Ground for the finish of the Annual Beer Race on the 17th June. The Club had submitted an earlier request but this had not been received by the Clerk.

RESOLVED -

That the the Chairmans action be endorsed.

(B) Dog and Crook 15K Race

Consideration was given to a request from the Dog Crook for the finish of their 15K Race to take place at the Recreation Ground on the 29th July.

That permission for this use be granted.
