## 103. MINUTES

### 104. POWER STATION, NORTH BADDESLEY

The Clerk referred to a letter from North Baddesley Parish Council which referred to a presentation from Anron Europe Ltd outlining proposals to build a power station at North Baddesley. The Parish Council were arranging a meeting for local Parish and Borough Council representatives in an effort to gauge local reaction to the proposal and to assess the way forward. # 108. VILLAGE POND

Councillor Tim Howkins reported on the reinstatement of the land surrounding the pond. He had obtained the necessary top soil and grass seed and was waiting for appropriate weather before carrying out the seeding work. The Chairman also referred to a letter he had received from Lucy Howkins and Anna Vrotsos who were seeking the Parish Council's support in the provision of a litter bin at the pond area. Lucy and Anna had already cleared the area of litter including an amount of broken glass.

### RESOLVED -

That Test Valley Borough Council be contacted to supply lockable litter bin on the pond area and that Lucy and Anna be thanked for their efforts in looking after the pond area.
