10. HIGHWAYS

The Clerk reported that the Area Surveyor would be undertaking repairs to the piped culvert at the junction of Dores Lane and Common Hill. The damage had been caused by a lorry negotiating the junction. The Clerk also reported that following a request at the Annual Parish Meeting he had sought information from the Area Surveyor about damage to the bollards at the Sandy Lane/Braishfield Road junction. The Area Surveyor had conformed that additional retaining wedges would be fitted to these bollards to help prevent vandalism. Reference was also made to the pit opposite Chalk Pit Cottage which was considered by Council members to be inadequately fenced and very dangerous.
