#### 156. MINUTES

AGREED that the Minutes of the Meeting held on 5th March 2002 are signed by the Chairman as a correct record.

#### 157. GOLDEN JUBILEE

NOTED that Mandy Payne and Alan Light reported that an additional sum of about £900 is required to cover all the activities currently planned.

AGREED that the Parish Council funds such a shortfall. Also agreed that the Clerk makes enquiries about public liability insurance with Cornhill for the event.

## 158. CODE OF CONDUCT

NOTED that a meeting has been arranged for Tuesday 9th April at 7pm with the intention of adopting the Code of Conduct.

AGREED that the Clerk lets **Andrew Lalonde** have samples of the declaration forms for copying.

## 159. ALLOTMENT FENCING

NOTED that the allotment fencing was originally put up by the Borough Council and therefore Mr Hoddinott does not consider it is his responsibility.

#### 160. AUDIT GUIDANCE

AGREED that the Clerk complains to HAPTC that the 'lighter touch' audit process does not appear to be any lighter owing to the obligation to appoint an 'internal' auditor to carry out much of the work previously done by the District Audit. Also agreed to purchase an audit guidance document from HAPTC.

## a) Infill policy

## 166. HIGHWAYS AND ROAD SAFETY

## a) Highway maintenance

NOTED that HCC has replied both to Alan Dowden and the Parish Council about concerns expressed over delays or inadequate maintenance.

AGREED that the Clerk creates a full list of highway concerns, including the standard of work at Bailey Down and the poor state of Dores Lane, and arranges for the Area Surveyor's local supervisor to attend a site meeting late one afternoon. Also agreed that the Clerk notifies the Area Surveyor of potholes on the bend at Crook Hill.

#### b) Verges

NOTED that Mike Evans has confirmed that the verges near Wyndhams are to be re-instated.

#### c) <u>Fingerposts</u>

NOTED that refurbishment of the Church Lane sign is awaited.

#### d) Bailey Down

NOTED that the re-surfacing of Bailey Down has already been deferred for six years and cost £17.600.

AGREED that the Clerk takes this up with Alan Dowden.

#### 167. FOOTPATHS AND POND

NOTED receipt of a letter from Michael Woodhall expressing support for the Pond project.

AGREED that the replacement of the seats will not be done until after the pond work has been completed. Also agreed that the Clerk informs HCC of the damaged footpath sign by the Wheatsheaf PH.

## 168. RECREATION GROUND

## a) Noticeboard

NOTED that a replacement noticeboard is on order and consideration is being given to replacing the official Parish Council board by the School with the damaged one after some refurbishment.

#### b) Tarmac

AGREED that the Clerk accepts the R&D quotation of £596 + vat for the repair of the car park tarmac damaged by the fire.
