41. CHAIRMAN
AGREED that Mike Edwards is Chairman for the Meeting.
42. MINUTES
AGREED that the Minutes of the Meeting held on 5th June 2002 are signed by the Chairman as a correct record.
43. POST BOX
NOTED that the Royal Mail has yet to respond to the request for a post box by the Recreation ground entrance.
44. GOLDEN JUBILEE
AGREED to make payments for the band (£100) and the visitors book (£25.49). The book is to be kept by the Clerk for any future similar occasions.
45. VILLAGE SHOP
AGREED that the Clerk investigates the latest Village Shop Committee report and circulates it if necessary. Also agreed that, subject to a minor change to the draft, the letter is sent to the Charity Commission asking it to respond to queries about the Recreation Ground Trust Deed from the Village Shop Committee.
46. PARISH NOTICEBOARDS
NOTED that the Clerk has not yet received the environmental enhancement grant application form from TVBC.
47. PARKING AT BUNGALOWS
AGREED that the Clerk asks Testway Housing about progress on the provision of parking by the Hill View bungalows.

NOTED that TVBC has asked if the Parish Council agrees to the boundary change with Romsey Extra, but that the Clerk has responded saying the proposal has been withdrawn.

- c) HCC Minerals & Waste Plan review
NOTED receipt of the Minerals part of the review and that the Waste part, which will be of more interest to Braishfield, is to follow.

d) Planning application circulation

NOTED the request for all Councillors to pass round planning applications on circulation more quickly in order to meet closing dates.

56. HIGHWAYS AND ROAD SAFETY

a) Highway condition

AGREED not to comment on mud on the road in Kiln Lane or Braishfield Road.

b) Traffic Calming

NOTED that a revised proposal on traffic calming is awaited from WS Atkins.

57. FOOTPATHS AND POND

Pond

NOTED that **Mike Prince** is to attend a meeting with HCC about the pond on 2nd August.

Footpaths

AGREED to make a very strong objection to the proposed change to Footpath 14 on the grounds that it would be an unjustified change to a perfectly satisfactory path and that the new path would be less satisfactory. The Clerk is also to enquire why the path should be moved.

NOTED receipt of consultation documents from DEFRA on obstructions and crime on Rights of Way which were passed to **Mike Edwards**.

58. RECREATION GROUND

a) Noticeboard

NOTED that the replacement noticeboard has been received and that **Mike Edwards** is to liaise with **Mike Prince** over its installation.

b) Tarmac

AGREED that the Clerk arranges £2500 of tarmac insurance cover at an annual cost of £7.56.

c) Skateboard

NOTED that the Clerk has obtained a grant application form but further information is awaited from **Mandy Payne**. Noted also that the siting of a ramp could be very difficult in order to avoid complaints about noise.

d) Recycling bins

NOTED that imminent modifications to the Village Hall entrance will require the recycling bins to be moved.

AGREED that the Clerk refers this to **Andrew Lalonde** before informing TVBC.

e) Village Hall

NOTED that the Section 106 agreement has been signed by Archstone Developments.

f) Flags

NOTED that the Clerk has yet to ascertain the cost of flags.
