1784. Apologies

Apologies were received from Ward Member Cllr Martin Hatley.

1785. Exclusion of Public

In accordance with the Public Bodies (Admission to Meetings) Act 1960 it was proposed to exclude the press and public after the last agenda item for discussion on a personnel matter.

1788. Public Participation

Little Beeches. A member of the public mentioned that Little Beeches was now for sale and that the houses had been moved one metre forward and the garages enlarged. New plans were on the Test Valley website Ref. 19/01620/FULLS. Cllr Brazier agreed to look into this and take forward.

The meeting resumed at 7:15pm.

1789. Chairman's Report

Flags flying dates. The Chairman had received a letter from a parishioner regarding the recent flag raising. The Chairman said this was an error of judgement, not done in accordance with Parish Council policy and regretted by those concerned. The date and rationale for raising the flags are reviewed annually and will be published for 2020.

1790. Correspondence

- A letter of thanks from Victim Support.
- Crook Hill footpath (FP9). Ashfield development Whitenap for 1200 properties. The application has not yet been submitted. Correspondence to be dealt with by the Clerk.

1791. Events & Training

Cllr Yalden reported on the Hampshire 2050 Parish Council event on 9th January 2020 and will attend the Rural Community Energy Workshop on 13th February 2020. Councillors to advise if they wished to attend.

1792. Reports on progressing/concluded matters:

• Village Design Statement (VDS) – Jimmy Chestnutt (Chairman VDS Review Committee) reported as follows:

The review and update of the 2002 VDS has been completed and comments and advice from Test Valley Borough Council's planners taken on board

A significant rewrite and change of layout have taken place and a number of new photographs introduced. However, more are required. A villager has offered his services at no charge. The draft is now with the publisher who will produce the draft online version of the document, although a projected delivery date is not available as yet. Although the text is almost as required, we still need the maps and diagrams being produced by Test Valley Borough Council and the aerial and ground photographs which we can take once we have the grant money and better weather, possibly April/May. However, neither of those inputs are on the critical path and we will be able to send the draft with the 2002 existing photographs to TVBC for review, before the 2019 maps and photographs are available. Separately, it would seem sensible to start the process of considering a Neighbourhood Plan (NP) now so that we can, for example, ensure that we have any photographic requirements of a NP are factored into VDS aerial contract.

Jimmy also reported that he had applied for the grant and is assuming a publication date around June. He also suggested that Cllr Brazier should take this matter forward and that we should use the annual meeting in May to promote the VDS.

The Chairman thanked Jimmy for all his hard work.

Footpaths

Footpath 9

There was a problem with a tree and mud, together with footpath 4. Cllr White suggested a consensus view – trim back vegetation as there had been complaints from parishioners. Cllr Knights agreed to walk the footpaths on 5th February and talk to the owner. The Chairman asked Cllr Knights to feedback.

Emergency Planning

It is necessary to resubmit drawings as they are to the wrong scale and it is also necessary to ascertain the noise that the generator will make. Cllr Knights to revise.

Traffic Working Party

The Chairman said that the council should take forward the issue of traffic data flow, but wait until the footpath had been finished.

• Crook Hill footway

The footway is due to be finished in March and there were no plans to concrete some of the grass. It was suggested that the path should be named the 'John Bevan Path' with a sign and that the official opening might be over Easter time.

We are currently awaiting dates for Braishfield. Cllr Knights said they will have them soon.

• Bus Shelter at Hillier Gardens

No further information to be reported.

Bye-laws for Braishfield Recreation Ground

Cllr White mentioned that he has hit a brick wall and he suggested sending an email to the head of Test Valley Legal department. The Chairman agreed to source the name of the Head of the Legal department.
