Chairman Jane Bennett thanked Cllr White for attending the Southern Area Planning Committee and speaking on behalf of the Council. Decisions on Little Beeches and 12 Hill View Road were unanimous.

With reference to the Braishfield Village Design Statement (pages 20 and 21)

- 10. To protect the open space nature of the village, back land development building in space behind houses or in gardens should be discouraged and strictly controlled.
- 12. Buildings should be in harmony with the surrounding landscape and should not dominate or overpower their surroundings.
- 13.Extensions, alterations and new building should strictly respect the inherent scale and setting of the settlement.
- 20.Planning applications should be supported by a street scene illustration showing adjacent properties, relative heights, building levels and style. We acknowledge that you have suppled a street scene however it is not accurate re the height of the Magnolia tree and the ridge height compared with the bungalows in Chapel Close.

The council also has the following concerns:

- The proposed house will be on Braishfield Road and therefore viewed with the Chapel Close bungalows and not the houses on Hill View Road. It is therefore completely out of keeping and does not sit comfortably with its surroundings. A more appropriate design would be to compliment the adjacent bungalows in height and design.
- Three cars will not safely be able to turn and drive out of the site. All cars should be able to exit in forward gear and clearly this is not possible.
- The driveway is positioned dangerously as it is directly opposite the entrance to the Village Hall.
- Invasion of privacy for neighbouring properties.
- Nitrates why has no offset site been identified.

# 2041 Planning Application - Hampshire County Council

 a) 21/00588/CMAS Revised application Salvidge Farm, Bunny Lane, Timsbury OBJECT - the council agreed to support the concerns of Michelmersh and Timsbury Parish in their letter dated 16<sup>th</sup> June 2021.

### 2042 Notice Boards

ACTION: Cllr White to chase HCC again and contact Cllr Alan Dowden for support. Possibly use the lengthsman to clear the paths in future.
