TVBC New Corporate Plan - makes a commitment to working with our communities, at "place (local) level". The first workshop took place on the 1st of August. The aim of the session was to bring together groups and organisations connected to the local area and to explore how TVBC can work to prioritise and deliver on community priorities in the next few years.

Planning matters - supported Braishfield Parish Council in its objection to a contentious planning application to build in the countryside which was a deviation from the Local Plan and the VDS.
